

**Betsuin 529 College Savings Program**  
**Application for 529 Savings Contribution**

**Betsuin 529 College Savings Program** is a College Savings Program that the Buddhist Church of Sacramento Adult Buddhist Association (ABA) sponsors for the benefit of the Buddhist Church of Sacramento and ABA Member Families. The Program is funded annually by the ABA Scholarship Education Fund. Donations/Contributions to the Fund are expressly for Scholarship and Education Programs of Buddhist Church of Sacramento youth.

ABA intends to make an annual “matching contribution of up to \$100” to 529 Savings Accounts of Betsuin, ABA Family Members and Families whose 529 Savings Program Beneficiaries are Dharma School Students, members of Betsuin Sports Program, Cub Scouts, Boy Scouts, Girl Scouts, Sakura Gakuen, and Jr. YBA.

Upon approval of the **Application for 529 Savings Contribution**, the stipend (contribution) will be made out to the Owner’s Account (as indicated in Item Number 8 of the Application) and mailed to the Owner. The Owner is expected to deposit the contribution in the 529 Savings Account. Each eligible youth is entitled to one annual 529 Savings Contribution per year.

**Specific Requirements:**

1. The Owner of the 529 Savings Account must be a Family Member of the Buddhist Church of Sacramento, Family Member of the Adult Buddhist Association, or Family Member of the Beneficiary.
2. The Beneficiary of the 529 Savings Account must be a current year Dharma School Student, member of Betsuin Sports Program, Cub Scouts, Boy Scouts, Girl Scouts, Sakura Gakuen, and/or Jr. YBA
3. The Beneficiary of the 529 Savings Account must be in Pre-School or in K-12<sup>th</sup> Grade.
4. The Owner (or other family member) must make a “matching contribution” of at least \$100 in the current year.
